### **Document Usage**

- The overall System Version
- The date of release

- Confirmation of whether or not the database triggers were re-built and re-applied (Date or N/A).
- Confirmation that any database changes are in place in the production database (Date or N/A).
- Confirmation that the sponsor has accepted the changes for release.
- Confirmation of who was notified of the system update, when they were notified and their role in the project
- Confirmation that the protocol version changes have been implemented in the eCRF at all relevant sites. This can be completed by opening a participant record at each site and confirming that the correct protocol version is implemented
- Confirmation that for studies implementing the use of questionnaires which contribute to end points, a source code has been included that will notify the trial inbox that questionnaires have been sent to participants. If the study uses a scheduled task to generate email and text notifications and/or re-generate missing CRF data queries, confirm that the scheduled task has been updated
